Date of Commencement

ENACTED by the House of Assembly of Benue State of Nigeria as follows;

1. This law may be cited as the Recurrent Expenditure LAW 2022 and shall be deemed to have come into force on 1st January, 2022.

Title and Commencement

2. [1]The Accountant-General may, when authorized by warrant under the hand of the Governor, source income for the Consolidated Revenue Fund of the State, during the year ending the 31st December, 2022 any sum not exceeding in the aggregate ₦98, 792,082,431.34 [Ninety-Eight Billion, Seven Hundred and Ninety-Two Million, Eighty-Two Thousand, Four Hundred and Thirty-One Naira, Thirty-Four Kobo] only.
[2] The sum specified above shall be Appropriated to the Heads of Expenditure as set out in the SCHEDULE to this Law.

[3] The sum specified in sub-section (1) above shall be appropriated for the services set forth in PART B of the SCHEDULE to this Law.

3. All Allowances Approved in the Estimates, except travelling allowances, shall be paid to the beneficiary through salary on monthly basis. **Payment of allowances through Salary**
4. No amount set out in the schedule to this Law or part thereof shall be withdrawn from the Consolidated Revenue Fund after the 31st December, 2022. **Restriction of withdrawal from Consolidated Revenue Fund**
